Students who accumulate two or more incomplete grades in a given term, or across multiple terms, may be placed on a Mandatory Leave of Absence by the Committee on Undergraduate Academic Standing until their coursework is finished satisfactorily. Mandatory Leaves of Absence provide an opportunity for students to finish incomplete courses and to address the issues that led to the incomplete work so that, when students begin courses for a new term, they are not burdened with work from past semesters.

This form should be filled out in consultation with your instructors and represent agreedupon goals and a schedule for you to finish any outstanding work for your incomplete courses.

In order to continue your enrollment in the Fall 2019 term, all incomplete work from courses in which you initially received incompletes ("I" or "II") must be confirmed finished and passing by instructors by Wednesday, September 11th, 2019. Your work can be confirmed finished in two ways: 1) a passing grade posted on Penn InTouch or 2) by instructor emails to Dr. Rebecca Poyourow confirming all work is completed and passing.

If you plan to take summer courses and are eligible for a mandatory leave, you will have an earlier deadline of Wednesday, May 22th 2019 to complete your incomplete work. If the only work that remains in the incomplete class(es) is for you to sit for a postponed final exam at the beginning of the fall term, then it is possible to have your instructor(s) provide confirmation that (a) that is the case and (b) that you have scheduled a postponed exam(s) for a specific date in the fall. If this deadline is not met, you will not be eligible to take summer courses at Penn or receive credit away for summer courses taken elsewhere.

If your incomplete work is not confirmed as finished by the September 11th deadline, you will be placed on a Mandatory Leave of Absence for the Fall 2019 semester and, depending on your academic standing, you will be eligible to apply to return to Penn when all outstanding work is completed.
